

## HURON SCHOOL DISTRICT ADVERTISEMENT FOR BID

Huron School District will receive sealed bid proposals for:

**Bid Package #5 Huron High School Site Work** until **2:00 p.m. on December 1, 2023**. Bids will be opened and publicly read aloud immediately following the deadline for submission. Huron School District will not consider or accept a bid received after the date and time specified for the bid submission.

Bids must be submitted electronically no later than 2:00 p.m. local time, December 1, 2023, at: <https://www.buildingconnected.com/>

Huron School District is not liable for any electronic or delivery delay. No bids will be received at any other location; all bids must be received by Huron School District at the website identified above.

A pre-bid conference will be held on November 13, 2023, at 1:00 pm on site. This meeting is optional, but a site visit is highly recommended due to existing conditions that must be addressed in the proposal. Meet at the east parking lot entrance to the high school, (between Renton Middle School and the high school). After a short presentation, we will walk to the location of the work at the south side of the school. **Wear hi-vis vest /etc.**

A Bid Security executed by a U.S. Treasury listed Surety Company acceptable to the Owner or a cashier's check in the amount of at least five percent (5%) of the bid must be included along with a statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the board, board of directors, or the superintendent of the School District. Bid Security in the form of a certified check is acceptable bid security **only** for proposal less than \$50,000. An Iran Disclosure Statement must also be included along with a Criminal Background Disclosure Affidavit and a Non-Collusive Affidavit. Accepted bidders may be required to furnish Performance and Payment Bonds in the amount of one hundred percent (100%) of the Contract Price.

All bids must be accompanied by a statement disclosing any familial relationship that exists between the Owner or any employee of the bidder and any member of the board, board of directors, or the superintendent of the School District. All bids must be accompanied by a statement to comply with the Iran Economic Sanctions Act of 2012. All bids must be accompanied by a Criminal Background Disclosure Affidavit. All bids must be accompanied by a Non-Collusive Affidavit.
